	Justice Arthur Emmett AO QC Justice Arthur Emmett was admitted as a barrister in New South Wales in 1978. He was appointed Queen's Counsel in 1985. Justice Emmett was a judge in the Federal Court of Australia from 1997 to 2013. From 2013 to 2015, Justice Emmett was a judge of Appeal of the Supreme Court of New South Wales and since October 2015 he has been an acting Judge of Appeal also sitting in the Commercial and Real Property Lists of the Equity Division.
10.00-11.10am	<b>Estate Litigation to Challenge Tainted Dispositions:</b> This topic considers some of the situations in which an estate might challenge dispositions of property that a deceased had made either inter vivos or by will, that were the product of influence, misrepresentation or pressure, or were made on the basis of a promise or undertaking that was later not kept. It also considers some of the various remedies that might be available in such situations.
	Professor Joe Campbell Professor Joe Campbell was admitted to the bar in 1975 and appointed silk in 1988. He was appointed to the Equity Division of the Supreme Court of NSW in 2001 and to the Court of Appeal in 2007, retiring from the Court in 2012. Since then he has been an Adjunct Professor at Sydney University, lecturing and writing in equity, interpretation, property and commercial law and legal history.
